1. East African Statistical Department. "The Balance of Payments of East African 1958, 1959, and 1960", p. 27 (mimeo). E.A. Statistical Department, E.A. Common Services Organisation.

Revised figures for 1959 and provisional figures for 1960.

2. H.W. Ord, "Growth of Money Incomes in East Africa". E.A. Economics Review, Vol. 9, No. 1.

Official estimates for the period 1954 and after extrapolated back to 1946.

3. C.P. Haddon-Cave. "Real Growth of the East African Territories 1954-60 - A Rejoinder". E.A. Economics Review, Vol.9, No. 1.

4. H.W. Ord. "Social Accounting and Inter-Territorial Transactions in East Africa." E.A. Economics Review, Vol. 9, No. 2.

Discussion of the treatment of the E.A. Common Services in the official G.D.P. calculations, and of territorial balance of payments.

Structure and ownership of physical assets, valued at "net book value" in 1958.

2. Colony and Protectorate of Kenya. "Economic Survey 1962", p.44 Government Printer. Provisional G.D.P. Figures for 1961.

2. Economics and Statistics Division. "Economic Survey 1963", p. 49 The Treasury.

First estimate of G.D.P. for 1962. A short Appendix describes the "adjustments made to the present series of gross domestic product estimates to take account of the results of the 1962 population census."

3. Economics and Statistics Division. "The Growth of the Economy 1954-1962", p. 18 (mimeo). Economics and Statistics Division, Ministry of Finance and Economic Planning.

This is a modified version of a paper prepared for the Planning and Development Advisory Council to "serve as a basis for a consideration of the rate of economic expansion that might be attained over the next six years".

4. Economics and Statistics Division. "Kenya Census of Manufacturing 1961", p. 90 (mimeo). Economics and Statistics Division, Ministry of Finance and Economic Planning.

A postal census of all firms with 5 or more employees which were classified as manufacturers in the index of employers maintained by the Division.

#### TANGANYIKA

Presents economic and functional analyses of the Central and Local government accounts and estimates and the appropriation account of general government (including E.A.C.S.O. and defence but excluding public transport and communication).

2. Tanganyika Government. "Budget Survey 1963-64", p. 29. Printed by the Survey Division, Ministry of Lands, Forests and Wildlife.

Gives preliminary estimates of G.D.P. for 1962.

#### UGANDA

##### 1963

1. Statistics Branch. "Background to the Budget 1963-64", p. 47 (mimeo). Statistics Branch, Ministry of Economic Affairs.

First estimates of G.D.P. for 1962 and forecast for 1963. Contains a short account of an enquiry made of large firms about their plans for capital expenditure over the next five years.

2. Uganda Government. "The First Five-Year Development Plan 1961/62 - 1965/66", p. 113. Government Printer, Entebbe.

"A plan for development in the public sector and an estimate of private sector investment during the period."

#### ZANZIBAR

##### 1963.

1. East African Statistical Department. "The Gross Domestic Product of the Protectorate of Zanzibar 1957-61", p. 17 (mimeo), E.A. Statistical Department, E.A. Common Services Organization.

Estimates based mainly on the "product" approach.

KENYA

1964.

1. Economics and Statistics Division. "A Kenya Index of Manufacturing Production", p. 13 (mimeo). Economics and Statistics Division, Ministry of Finance and Economic Planning.

An Index derived from miscellaneous series, taking 1961 as base year. The calculations are carried back to 1954.

2. Economics and Statistics Division. "Economic Survey 1964", p. 59 The Treasury.

First estimate of G.D.P. for 1963.

3. Government of Kenya. "Development Plan 1964-70", p.137. Government Printer.

The two sections of particular interest for national accountants are "Growth of the Economy, 1954-1962" and "Economic Implications of the Plan".

4. B. van Arkadie. "The Structure of the Kenya economy", p. 5 (mimeo.) Proceedings of the E.A.I.S.R. Conference, January 1964, Makerere, Kampala. "...a tentative step towards a larger study of the growth and structure of the East African economy."

TANGANYIKA

1964.

1. Central Statistical Bureau. "Census of Industrial Production in Tanganyika, 1961", p. 109 (mimeo.). Central Statistical Bureau.

"The present census ... covers all industrial establishments in Tanganyika, irrespective of size." In addition to the normal purview of industrial production coverage "was extended to include primary processing of agricultural raw materials, such as sisal, carried out on agricultural estates."

2. Tanganyika Government. "Budget Survey 1964-65, p. 20. Government Printer.

Gives estimates of G.D.P. for 1963, and of agriculture for 1960-63 at constant (1960) prices.

3. Central Statistical Bureau, "The National Accounts of Tanganyika 1960-62", p.76 (mimeo) Central Statistical Bureau, The Treasury.

Describes a new official calculation. The total G.D.P. figures do not differ very much from those given by the previous calculation, but the distribution between sectors is considerably changed. The basis of the calculation in the subsistence sector has also been changed and is now more comparable with the treatment in the Kenya and Uganda calculations. One section deals with estimates at constant prices.

4. United Republic of Tanganyika and Zanzibar. "Tanganyika Five-Year Plan for Economic and Social Development 1st July 1964-30th June 1969. Volume 1: General Analysis", p. 114. Government Printer.

Much of the description of the Plan is made within a national accounts framework.

A series for 1954-1962 of G.D.P. at factor cost valued at 1960 prices, with a discussion of the methods used.
