Khalid Ali is a lawyer and the Director of the Egyptian Center for Economic and Social Rights and formerly worked for the Hisham Mubarak Center for Legal Aid. He helped establish the Popular Committee to Support the Palestinian Intifada in 2000, is very active in the labour movement and the youth movements, in particular the April 6th movement. He played a critical role in liaising between different political forces at the time of the Egyptian uprisings.

Omar S. Dahi is Assistant Professor of Economics at Hampshire College, USA. His research interests are in the areas of economic development and international trade, with a special focus on South–South economic cooperation and the political economy of the Middle East and North Africa.
