Notes on Contributors

Kassa Teshager Alemu* is Assistant Professor at the Ethiopian Civil Service University, Addis Ababa and Deputy Director for the Research and Community Service in the College of Finance, Management and Development. He holds a BA in Development Management (Ethiopian Civil Service University), an MA in Local and Regional Development (International Institute of Social Studies, Erasmus University) and a PhD in Development Studies (University of South Africa). His research interests include: social protection and rural/urban poverty alleviation strategies; rural development, livelihoods and food security; as well as decentralisation and local governance.

Fatai A. Aremu* is Associate Professor in the Department of Political Science, University of Ilorin, Nigeria. He holds a PhD in Asia Pacific and Development Studies (Ritsumeikan Asia Pacific University, Japan). Fatai is currently the Policy, Budget Analysis and Legislative Advocacy Manager at the Development Research and Projects Center (dRPC), Abuja, Nigeria. His research covers public policy analysis, comparative political institutions, international political economy, Asia Pacific and development studies. He is the author of *Asymmetrical Foreign Policy Behaviour of Japan and China* (College Press & Publishers, 2011). He is co-editor (with H.A. Saliu) of *Introduction to International Relations* (College Press & Publishers, 2012).

Richard C. Crook is an Emeritus Fellow at IDS. He holds a PhD from the London School of Economics and Political Science (LSE), University of London and is the co-author of *Democracy and Decentralisation in South Asia and West Africa* (Cambridge University Press, 1998) and *The Law, Legal Institutions and the Protection of Land Rights in Ghana and Côte d'Ivoire* (Institute of Development Studies, 2007). He was the Director of the Institute of Commonwealth Studies (University of London). He has worked mainly in West Africa and South Asia on governance and administration, state-civil society relations, the justice sector and land rights.

Daniel Doh* is a social policy analyst and researcher. He worked previously as a Research Fellow at the Centre for Social Policy Studies, University of Ghana where he taught graduate-level research courses. Daniel's research interests include social protection services, institutions of governance, ageing and vulnerability, and impact evaluation. He has consulted on various research projects within and outside Ghana. He is currently a final year PhD candidate and Research Associate at the Edith Cowan University, Western Australia.

Eunice Kamaara* is Professor of Religion at Moi University, Kenya and International Affiliate of Indiana University-Purdue University Indianapolis. She holds a doctorate in African Christian Ethics, and an MSc in International Health Research Ethics. Her research focuses on
