

# Covid-19, Conflict, and Governance Evidence Summary No.8

This weekly Covid-19, Conflict, and Governance Evidence Summary aims to signpost DFID and other UK government departments to the latest evidence and opinions on Covid-19 (C19) to inform and support their responses.

This week, features resources on: a C19 conflict sensitivity tool; a database on ceasefire updates; C19 lessons from the 14<sup>th</sup> century Black Plague; and perceptions about European cooperation related to C19.

Many of the core C19 themes continue to be covered this week, including: C19 and increasing gender based violence; the shifting global order; C19-related corruption; and the heightened vulnerability faced by children, refugees and internally displaced people.

The summary uses two main sections – (1) literature: – this includes policy papers, academic articles, and long-form articles that go deeper than the typical blog; and (2) blogs & news articles. See the end of this report for details on the method taken for this rapid summary. It is the result of one day of work, and is thus indicative but not comprehensive of all issues or publications.

In sickness and in health: European cooperation during the coronavirus crisis; and Coronavirus Special Survey	Claire Busse et al.; European Council on Foreign Relations; Survey	<ul> <li>How has C19 affected European cooperation and how has the European Commission performed?</li> <li>Based on a perception survey of 744 policy professionals from EU countries in March and April, responses indicate that during C19:</li> <li>A majority of respondents in most EU countries said there has been less overall cooperation between member states than they would have been expected. With exceptions - Germany, Ireland, Cyprus, Latvia, and Portugal - where a majority of respondents said there has been about as much cooperation between member states as expected.</li> <li>Germany was considered the bloc's undisputed crisis leader. It made a shaky start in showing solidarity, but later regained trust related to health and the economy. The Netherlands is considered the leading 'frugal' state opposing greater financial burdensharing.</li> <li>A majority of respondents in most EU countries said they thought the European Commission has done what it can during C19, given its competencies. And three in ten</li> </ul>

		respondents believe it excelled in playing a constructive role. The EU institutions won few plaudits but policymakers still look to it for post-crisis economic leadership.  France emerged at the head of a strengthened 'southern' grouping of member states, while the Visegrad platform was invisible during this crisis.
COVID-19 Impact on the Value Chain in Latin America	Karolien van Teijlingen and Barbara Hogenboom; Clingendael; Policy Brief	How has C19 impacted employment and labour rights in the Colombian and Peruvian large-scale mining sectors? This policy brief finds mining, and related informal economies around mining, have been negatively impacted by low commodity prices and demand, interrupted supply chains, national lockdowns and the (partial) closure of operations. Companies have attempted to reduce costs on the back of their labour force, with layoffs, renegotiations and suspension of contracts. Outsourced workers and informal economy workers (the latter mostly women) are worst affected. In the long-term, labour rights are likely to decrease. Companies and investors operating in Latin American commodity sectors should put social and economic justice at the centre of their operations.
Comparing Covid-19 to the Black Death in Europe	John Aberth; World History Bulletin; Article	How does the 14 <sup>th</sup> century Black Death pandemic compare to C19? The Black Death caused tremendous economic and social upheaval by creating an enormous demand-side shock for goods and a supply-side shock in available labour due to the high mortality. These changes in supply and demand meant lords had to pay much higher wages, or other concessions, and received much lower prices for the largely agricultural goods they produced. It was largely because of the Black Death that serfdom waned in western Europe by the end of the Middle Ages. The Black Death returned at periodic intervals to keep population, supply, and demand at its new low level for at least a century after 1348.
Bangladesh: Short and Long Term Impacts of Existing Covid-19	ACAPS; Report	How is C19 affecting Rohingya refugees in Bangladesh? This report finds C19 is suspected of having spread extensively through the Rohingya refugee camps with severe

Containment Measures in Rohingya Refugee Camps	consequences. Humanitarian agencies should shift from testing to treatment and care, with more focus on improving trust in health facilities and camp authorities, as mistrust has led to low consultation rates and a lack of willingness to report symptoms and to consent to testing. Disaster risk mitigation and preparedness activities are essential given the coming monsoon season. The reintroduction of protection as an essential service could reduce the use of negative coping strategies.

COVID-19 and Gender- Based Violence: Workplace Risks and Responses	International Finance Corporation; Guidance Note	How is C19 affecting gender-based violence in the workplace? This note finds C19 increases workplace risks of: customer and client aggression, workplace bullying, workplace sexual harassment, sexual exploitation and abuse connected to the workplace, and domestic violence. Victims may be reluctant to report abuses due to power differentials, reduced access to support services, or mobility restrictions. Employers should encourage employees and bystanders to report incidents.	
Impact of COVID-19 on child labour in South Asia	Iffat Idris; K4D/GSDRC, IDS; Helpdesk Query	How did previous epidemics and crises affect child labour in South Asia? Previous epidemics and financial crises led to a rise in child labour across the developing world, including South Asia. Loss of informal sector jobs, rising poverty, and lack of social protection could force families to turn to child labour to survive. Children already	

		working could face harsher conditions, with lower pay and longer hours. Agriculture and the garment industry could see a rise in child labour, but otherwise there is a lack of disaggregated data.
The COVID-19 Crises and the Coming Cold War	John Hemmings; Daniel K. Inouye Asia- Pacific Centre for Security Studies; Journal article	How is C19 affecting world order? This journal article argues C19 has reinforced geopolitical competition between the US and China, with a coming cold war. Key issues: (1) China is projecting blame to retain legitimacy and social order at home, as a brittle superpower; (2) ideological differences are again a key characteristic of great power relations; and (3) the geopolitical competition is unlikely to lead to actual warfare, but a discourse battle for hearts and minds. This competition is likely to dominate the international system until the middle of this century, because of size of the two countries and their resources.

#### Methodology

Due to the emerging nature of the Covid-19 crisis, this rapid weekly summary includes blogs, and news articles, in addition to policy and academic literature. The sources included are found through searches of Google Scholar, Google, and ReliefWeb with the keywords:

("COVID-19" OR "coronavirus") AND ("developing countries" OR "Africa" OR "Asia" OR "Middle East" OR "Latin America" OR "Pacific") AND ("conflict" OR "peace" OR "violence" OR "resilience" OR "fragility") OR ("authoritarian\*" OR "democra\*" OR "corrupt\*" OR "transparency" OR "state legitimacy" OR "non-state actors" OR "state capacity" OR "state authority" OR "politic\*" OR "state institutions")

The searches are restricted to articles published in the previous seven days, in English. This is complemented by: a focussed Twitter search (using just the pages of a small selection of research organisations, and key scholars/thinkers, including those funded by the UK government's Department for International Development (DFID)); and through email recommendations from DFID advisors and leading experts.
