

Covid-19, Conflict, and Governance Evidence Summary No.16

This weekly Covid-19, Conflict, and Governance Evidence Summary aims to signpost the UK Foreign, Commonwealth and Development Office (FCDO) and other UK government departments to the latest evidence and opinions on Covid-19 (C19), to inform and support their responses.

This week features resources on: how to address C19 health risks during elections in Nigeria; the effects of a Universal Basic Income during C19 in rural Kenya; and the need to engage youth and youth groups in C19 responses to build back better and address intergeneration inequalities.

Many of the core C19 themes continue to be covered this week, including: the roles of non-government organisations in C19 responses; C19-related corruption, particularly involving state graft cases and medical procurement; and the unequal impacts of C19 on specific groups: children and sexual violence, attacks on health and aid workers; and border issues with migrants and displaced people.

The summary uses two main sections - (1) literature: - this includes policy papers, academic articles, and long-form articles that go deeper than the typical blog; and (2) blogs & news articles. See the end of this report for details on the method taken for this rapid summary. It is the result of one day of work, and is thus indicative but not comprehensive of all issues or publications.

Indonesia's fight against COVID-19: the roles of local government units and community organisations	Mahir Pradana, Nurafni Rubiyanti, Wahyuddin S., Imanuddin Hasbi, and Dian Gutami; The International Journal of Justice and Sustainability; Journal article	How are local government units and community organisations contributing to the C19 response in Indonesia? This report find that, as smaller units under the Indonesian government, local government units and community organisations are playing an active role ensuring welfare for the poor and elderly during C19, acting as an extension of the central government. One of the most effective ways to ensure Indonesian older adults' safety is by involving their families and neighbours – e.g. to make sure they do not travel outside their houses unless there is an urgent need, that they use masks, and regularly wash their hands. Youth groups (<i>Karang Taruna</i>) operate under most local government units, and are essential in channelling aid from government to community units and beneficiaries.
Effects of a Universal Basic Income during the pandemic	Abhijit Banerjee, Michael Faye, Alan Krueger, Paul Niehaus, Tavneet Suri; Innovation for Poverty Action; Working Paper	What are the effects of a Universal Basic Income (UBI) during C19 in rural Kenya? Based on a large-scale experiment, this paper finds that transfers significantly improved well-being on common measures such as hunger, sickness and depression in spite of C19, but with modest effect sizes. They may have had public health benefits, as they reduced hospital visits and decreased social (but not commercial) interactions that influence contagion rates. During the pandemic (and contemporaneous agricultural lean season) recipients lost the income gains from starting new non-agricultural enterprises that they had initially obtained, but also suffered smaller increases in hunger. This pattern is consistent with the idea that UBI induced recipients to take on more income risk in part by mitigating the most harmful consequences of adverse shocks. Policy

		Implications include recognising that the UBI is not designed to respond to extreme, unanticipated crises like C19, so there is a need to build the infrastructure to make additional universal cash transfers that can be activated at short notice and can be used to deliver additional cash in response to unanticipated crises like C19.
Guidance Note: Transparency, Accountability and Anti- Corruption Service Offer for COVID-19 Response and Recovery	UNDP; Guidance Note	How can transparency, accountability and anticorruption measures be integrated in C19 response and recovery priorities? This guidance note highlights how corruption in C19 responses is limiting access to lifesaving resources and medical equipment, distorting economic recovery packages, diverting aid from affected populations, undermining public trust with government, reducing compliance with public health messages, and can fuel instability and conflict. It identifies major corruption risk areas as: procurement, service delivery, emergency funds, and policymaking.
Vulnerability of children in Botswana during COVID- 19	Thabile A Samboma; SAGE Journals, Journal Article	How is C19 affecting child vulnerability in Botswana? This journal article finds that Child sexual abuse (CSA) in Botswana is high under C19 due to economic insecurity, poverty-related stress, quarantines, exposure to 'unhealthy' relationships, and reduced access to health services and first responders. CSA cases are often not reported due to stigma and as many perpetrators are family. Poverty sometimes drives children into prostitution. Online education has increased exposure to online pornography.
People Movement in Mexico	ACAPS; Report	How is C19 affecting migration and displacement? This report finds that C19 is being used to further Trump's agenda to block immigration and asylum indefinitely, with many stuck in limbo on the Mexican side of the border. It has also provided criminal groups with an opportunity to intensify activities and exert greater influence over local populations, while the state is distracted by managing the escalating C19 health crisis.

This report identifies over 78 events where aid or health workers were killed, kidnapped, injured, or assaulted, and 103 events where health facilities were damaged or destroyed, including:
		India: Over 145 health workers were injured or assaulted by police officers, local community members and relatives of C19 patients due to fears of infection or opposition to C19 screening or burial procedure
		 Indonesia: 6 health workers were injured by local community members reacting to C19 health measures.
		 Mexico: 24 health workers were injured or assaulted by local community members.
		DRC: 5 health workers were kidnapped, Health Clinics and Ebola Treatment Centres were destroyed or set on fire.
Elections amid Covid-19 and public safety	Nextier SPD; Weekly bulletin	How will public safety related to C19 be affected by elections in the upcoming elections in the Nigerian states Edo and Ondo? This bulletin highlights how violations of C19 protocols in the elections portend dire consequences for public safety, for the already stretched health facilities, and could prompt a return to restrictive lockdown measures. It recommends:
		A shift from conventional campaigns to alternative means of electioneering using online and digital technology
		 Inter-agency partnership between Nigeria's Independent National Electoral Commission and other government agencies
		Effective public communication including public service announcement video and radio

messages and posters with elections and C19 protocol information
 Safe polling and result collation environments – so that polling booths are well ventilated and safe for social distancing. Polling booths should open early to avoid overcrowding.
 Proper use of security operatives to ensure C19 protocol compliance and other electoral guidelines. Security personnel should be adequately trained.

'Building Back Better': Youth, Risk and Resilience in the coronavirus (COVID-19) Pandemic	Graeme Simpson and Ali Altiok; Accord; Blog	How to build back better from C19 through youth resilience? This blog finds that C19, and C19 responses, feed into, feed off, and trigger preexisting local, national, and global patterns of inequality and exclusion; with generational and gendered manifestations. C19 responses have increased the political exclusion, marginalisation, and powerlessness of young women and men. Particularly young men are now more exposed to the criminal justice system, and state security forces, through curfews, states of emergency, and enforced lockdowns. C19 has entrenched negative stereotypes of young people based on

		the minority that are not following C19 guidance, yet this further alienates young people and widens mistrust. C19 has increased youth vulnerability by limiting access to decent jobs and education, and due to unequal digital access at home, and being exposed to cyber crime and other threats. However, as youth face lower health risks, they can be engaged to mitigate risk and in community outreach strategies. Engaging youth-led social movements could foster more transformative forms of resilience building to build back better and address underlying inequalities.

This blog explains how the economic impact of C19 threatens to undermine various sectors of the economy that are crucial for government revenue collection thus putting further strain on the state-building project in Somalia.
Rio de Janeiro governor suspended over alleged COVID-19-related graft	Rodrigo Viga Gaier; Reuters News	A Brazilian court temporarily removed Rio de Janeiro state's governor from office over alleged graft in the purchase of C19 medical supplies and services. The 180-day suspension is a major blow for Governor Wilson Witzel, a self-proclaimed law-and-order politician who rose from virtual obscurity to win the governorship of Brazil's second-most important state in 2018.
Coronavirus denialism still holding Africa back	Cai Nebe; DW; News	Denialism is impeding the ability of African governments to curb the spread of C19. State corruption, poor communication, and distrust across Africa make conspiracy theories tempting. E.g. President John Magufuli declared Tanzania C19-free in June, and it has stopped publishing data on C19 cases. Others see C19 as a way for corrupt officials to capitalise on aid handouts.

Methodology

Due to the emerging nature of the Covid-19 crisis, this rapid weekly summary includes blogs, and news articles, in addition to policy and academic literature. The sources included are found through searches of Google and ReliefWeb with the keywords:

("COVID-19" OR "coronavirus") AND ("developing countries" OR "Africa" OR "Asia" OR "Middle East" OR "Latin America" OR "Pacific") AND ("conflict" OR "peace" OR "violence" OR "resilience" OR "fragility") OR ("authoritarian*" OR "democra*" OR "corrupt*" OR "transparency" OR "state legitimacy" OR "non-state actors" OR "state capacity" OR "state authority" OR "politic*" OR "state institutions")

Plus searches of Google Scholar with the keywords:

("COVID-19" OR "coronavirus") AND ("developing countries" OR "Africa" OR "Asia" OR "Middle East" OR "Latin America" OR "Pacific")

The searches are restricted to articles published in the previous seven days, in English. This is complemented by: a focussed Twitter search (using just the pages of a small selection of research organisations, and key scholars/thinkers, including those funded by the UK government's Department for International Development (DFID)); and through email recommendations from DFID advisors and leading experts.
