Challenges include the need to get information quickly in disasters; the need for community engagement and permission; the costs of buying and transferring images, and the skills needed to interpret them; limits on infrastructure availability (e.g. planes, drones); lack of co-ordination between organisations; and linking the data to decision-making.

It argues that covid is a syndemic (characterised by 'biological and social interactions between conditions and states, interactions that increase a person's susceptibility to harm or worsen their health outcomes') and is exacerbating the already high prevalence of mental health problems among Syrians in Syria and abroad. It argues for responses that connect sectors, and using Syrian researchers more.

It identifies the following barriers: 'collective approaches to CCE are not understood in the same way by all stakeholders; they lack buyin at the leadership level; they lack access to predictable funding; and they are not well informed by existing local CCE practices, in large part because they fail to adequately involve local actors'. Based on a desk-review, key informant interviews, and case studies (published separately), the study discusses the terminology, different models of CCE, and principles for successful CCE.

However, the understanding of local leadership as 'traditional' and static 'could not effectively take into account how power dynamics and the legitimacy of local leadership were contested, renegotiated and produced, including through community engagement efforts and Ebola regulations themselves'.

Findings indicate that there are many local actors working in distinct groups isolated from the larger system. International actors and government 'were found to be helping to connect local organizations within the larger disaster preparedness and resilience system'. However, this meant that local actors were often reliant on international actor, who should work to help improve connectivity between local actors. Relationships were mainly one-way rather than recipircol.

The searches are restricted to articles published in the previous month, in English. This is complemented by email recommendations from DFID advisors and leading experts.
