We will protect your confidentiality and privacy throughout the interview. Your name will not be recorded, and we will not record any personal identification details. Your answers will be kept completely confidential and will be combined with all of the other people we are talking too. It will be impossible to pick you out from what you say, so please feel like you can speak freely. Although your identity may be known in town (since we came to visit you), it will not be associated with the study data. The study data will only be used by the DRC, and no records will be shared with any other organizations, actors, or officials. If you are at any point worried about confidentiality or privacy, please let me know.

Part 1

To start the interview, I would like to as you some questions about what sort of public services are offered in your community and how these are financed. Please remember that if you do not feel comfortable, you can choose to not answer some questions or end the interview.

- 1. What key public services are provided in your community?
 - Who is involved in these public services?
 - o How does the community finance these services?

Prompts for researchers: These could be things such as who provides water, electricity, healthcare, security etc. Could be provided by private sources, public sources, or the community at large.

- 2. Are there any community development projects that exist in your community?
 - o Who is involved in these projects?
 - How does the community finance these activities?

Prompt for researchers: Ask about projects where just the community has inputs, and also ask about projects jointly run by the community and the government. For example, a community-only project could be a community center built and run by citizens with no government help. A joint project could be where provides labour and gravel to build a road, and the government contributes the machinery.

Prompt: For example, low revenue potential, taxpayer's inability to pay, lack of skilled tax collectors, security issues, or others. We want to understand the difficulties they have in collecting the above payments and fees.

Thank you for all of your answers. Now I would like to move into the next part of the interview. I would like to ask you some deeper questions about the networks and groups within your community. We want to understand who works together on services and revenue collection in the community, and what kind of roles they play. If you feel uncomfortable at any point, please let me know. You can choose not to answer any question, or stop the interview if you want. Do you want to continue?

15. How effective do you think community groups are at collecting payments and fees from citizens? This includes clan groups, civil society groups, or other community groups, but not the local administration.

Prompt: This does not include any administration-collected revenue, but could include clans, community groups, or religious groups. Do they think it is effective, somewhat effective, or not at all effective? For example, collecting money from community members for community contributions for emergency relief.

16. How effective do you think tax collection by the local administration is in your community?
Prompt: We want to understand what they think about the ability of the local administration to collect taxes. Do they think they are very effective (can collect fees well) and why, or do they think they are not effective (they can't really collect fees) and why?
17. Say you are collecting fees or payments from community members, such as the Qaaraan. What does the population receive if they make this payment?
Prompt: Examples could include things such as access to services, general development, avoidance of stress/harm, security, good relations, or others. We want to understand what people receive if they make a payment to their clan or religious group. If you are asking to a clan leader, use Qaaraan as an example. If you ask a religious leader, ask zakhat as an example.
18. Say you are collecting fees or payments from community members, such as Qaaraan. If someone refused to make this payment, what would happen?
Prompt: This could includes things such as being given a fine, being harassed, not being able to access services, or others We want to understand what will happen if people do not make payments to their clan or religious group. If you are asking to a clan leader, use Qaaraan as an example If you ask a religious leader, ask zakhat as an example.

Prompt: For example, the local government authorities, other traditional leaders?

This does not mean that the project is going to happen, we just want to get your ideas and opinions about what would work in your community. As I mentioned before, all of your answers will be kept confidential and private. You may choose not to answer any questions that you do not feel like answering. Is it okay to continue?

26. Do you consider increasing your ability to collect fees and payments a priority? Why or why not?

Prompt: We want to understand if increasing their ability to collect fees and payments for services, activities, projects or security is important to them. For example, maybe currently they are restricted in access to the population and can't access Qaaraan contributions; they then want to strengthen their ability to collect revenue. Or for example they already have a very strong revenue collection system, and they don't think this is a very important priority for them. Describe why or why not.

27. Do you have suggestions for addressing any challenges you face in collecting payments and fees from the community?

Prompt: If they have challenges collecting fees or payments, what would make this easier for them to do?
