Khurshid Alam is a disaster and climate change specialist with experience in 25 countries in Asia and Africa. He was ActionAid's Emergency Policy Advisor in London and later managed a six-country tsunami response programme until becoming the Managing Director of ThinkAhead Limited in 2006. He writes on humanitarian and climate change issues. As a consultant, he has advised developing disaster risk reduction and climate change adaptation strategies, policies and projects for governments in Malawi and Cambodia, bilateral and UN agencies, international NGOs and the Red Cross. An anthropologist by training, he currently lives in Dhaka.

Jeremy Allouche is a Research Fellow at IDS specialising in international political economy and global environmental governance.
