

# Notes on Contributors

**Gabriela Alcaraz V.** is a freelance research consultant in the field of agriculture and rural development, based in Washington DC. She holds a PhD in Agriculture from the University of Hohenheim and an MSc in Tropical and International Agriculture from the University of Göttingen, both in Germany. She possesses further academic training in geographic and spatial analysis. Her research background and teaching experience cover topics of poverty measurement, food and nutrition security, agricultural development and development policy. At the onset of the project, she was appointed Regional Research Coordinator for Oxfam in the Latin America and the Caribbean region.

**Nick Chisholm** is a Senior Lecturer in International Development at University College Cork, Ireland. He focuses on hunger and food security analysis, and on sustainable natural resource management. He has worked as a development practitioner in Bangladesh and Ethiopia. For the last three years he has been leading a multi-institutional research project on agriculture–nutrition linkages in Ethiopia and Tanzania.

**Dinh Thi Bao Linh** (MDE) is Vice-Director of the Information Centre, Institute of Policy and Strategy for Agriculture and Rural Development (IPSARD). She is experienced in policy assessment, particularly on food safety and was co-ordinator of the IPSARD project Food Safety in Small-scale Production in Vietnam, supported by the VredesEilanden Country Office (VECO) Vietnam (2012–14).
