Hussainatu J. Abdullah is a sociologist and an independent scholar with extensive research and consultancy experience in West Africa. She has provided consultancy services for the Swedish NGO Foundation on Human Rights, International Labour Organization (ILO), UNFPA, UNICEF, Ford Foundation and the African Union, on women's human rights, democracy, labour and employment relations and post-conflict reconstruction processes.

Mulki Al-Sharmani is Assistant Professor of Anthropology at the Social Research Center, at the American University in Cairo. She is also adjunct teaching faculty at the Institute for Gender and Women's Studies, and the Center for Migration and Refugee Studies at the same university.

Andrea Cornwall is a social anthropologist, and works on gender, sexuality, rights and participation. She is Director of the DFID-funded Pathways of Women's Empowerment Research Programme Consortium (RPC). Her main interest is the study of women's participation in political spaces and she has been working on gender, citizenship, political behaviour, public policy and feminism. In addition she is a consultant for the UNIFEM/State Secretary for Promotion of Equality programme – SEPROMI.

Lopita Huq is a Senior Research Associate at the BRAC Development Institute working on the Deepening Democracy, Building Citizenship and Promoting Participation research project since April 2007. Her main areas of experience include qualitative research on adolescents, marriage, dowry and recently on studying grassroots
