## **Notes on Contributors**

Oga Steve Abah is Professor of Theatre for Development (TFD), and Director of the Institute for Development Research at Ahmadu Bello University, Zaria, Nigeria. He is a leading theorist in TFD, an area in which he has done research since 1980. His current research has focused on the interaction of methodologies, especially between TFD, participatory learning and action and participatory video. Professor Abah is the Nigeria Country convener for the Development Research Centre on Citizenship, Participation and Accountability. His other research interests are in development communication and community development.

**Ogho Alubo** studied sociology in the Ahmadu Bello University Zaria, Nigeria and in the University of Missouri Columbia, USA. He has conducted research and published on several aspects of healthcare development including inequalities in access and in HIV and AIDS. His recent research interests include the thorny issue of citizenship and national integration in multi-ethnic Nigeria. A past Director of Research of the National Institute for Policy and Strategic Studies, Kuru, Alubo is currently Professor of Sociology in the University of Jos.

Adam Baird is a PhD candidate at the Peace Studies Department of Bradford University. His current research investigates urban violence, youth and masculinities in Medellín, Colombia. Since 2001 he has focused on the Colombian conflict through his work in academia and in NGOs, including Peace Brigades International and The International Office for Human Rights – Action for Colombia.

Colette Harris is Senior Lecturer in conflict, governance and development in the School of Development Studies, University of East Anglia, where she directs graduate courses in conflict and in theatre and development. Her main research interests are the relationship of masculinities to violence and conflict and the development of transformative grassroots pedagogies emphasising gender identities. Colette was previously a Research Fellow at IDS and active in the Violence, Participation and Citizenship group of the Development Research Centre. She spent much of the 1990s in Tajikistan running a community development project and carrying out research on which she has published extensively. She now works mainly in East and West Africa.

Her research focuses on issues of violence and gender in Central America.
