

# Notes on Contributors

**Alexandra Abello Colak** is a doctoral student at the University of Bradford. Her academic work focuses on the links between security and participation, the transformation of global and local security paradigms and the provision of security in communities affected by inequality and violence. She has published articles in English and Spanish on community policing in Colombia and on other aspects of the relationships between state and society in contexts of violence and reconciliation.

**Mustapha Kamal Al-Sayyid** received a PhD from the Graduate Institute of International Studies in Geneva, and teaches Political Science at Cairo University and the American University in Cairo. He has also taught at Harvard and Colgate universities and been a visiting scholar at the University of California, Los Angeles (UCLA). He ran the Center for the Study of Developing Countries of Cairo University during 1995–2004 and is the Director of the think tank ‘Partners in Development’, in Cairo. He has published in Arabic, English and French on issues of political economy of development, political theory, civil society and human rights in Arab countries.

**Niagale Bagayoko** is a Fellow of the IDS. She is a political scientist with a doctorate from the University of Paris. She has published widely, including a 2003 book on US and French security policies in Africa (*Afrique: Les Stratégies Française et Américaine*) and three other volumes. She is currently researching sector reform in francophone African countries and led field research in Central African Republic, Cameroon, Mali and Senegal. She has also studied interagency and multilateral processes in post-conflict environments; subregional security mechanisms in West Africa (ECOWAS); and African conflict-management mechanisms.

**Sunil Bastian** is a political economist. His research interests cover the politics of capitalist development, ethnic conflict and state reforms

and the role of foreign aid in these processes in Sri Lanka. He has published widely, his most recent book being *The Politics of Foreign Aid in Sri Lanka, Promoting Markets and Supporting Peace* (Colombo: International Centre for Ethnic Studies 2007).

**May Chartouni-Dubarry** is a Senior Research Fellow in Middle-Eastern studies and a consultant with several international think tanks. She is preparing a book entitled *The Lebanese–Israeli Conflict: A Prospective Analysis* (forthcoming 2011).

**Anuradha M. Chenoy** is Professor at the School of International Studies, Jawaharlal Nehru University (JNU). She has been chairperson and Director of the Russian and Central Asian Studies at JNU. She has written many books and articles, including a recent co-authored book (with Shahrbanou Tadjbakhsh) on *Human Security. Concepts and Implications* (London: Routledge 2007). She has also been actively involved with many peace groups and NGOs.

**Gastón Chillier** is a lawyer with degrees from the University of Buenos Aires and the University of Notre Dame. He is the Executive Director of the Centre for Legal and Social Studies (CELS), an NGO established in 1979, during the military dictatorship, which has since worked towards strengthening the institutions of democracy and upholding human rights and the rule of law. Prior to this, he was Director of the Global Rights’ Latin America programme, and Senior Associate in Human Rights and Security at the Washington office of Latin-America (WOLA).

**Lucia Dammert** is the Director of the Program on Security and Citizenship at the Faculty of Latin American Social Sciences (FLACSO), Chile. She has worked in academic institutions in the United States and Argentina, as well as in the Chilean Interior Ministry. Her articles and books on public safety, police, and community

participation include *Security and Police Reform in the Americas* (with John Bailey, 2006) and *Ciudad y Seguridad en América Latina* (with Gustavo Paulsen, 2005).

**Neloufer de Mel** is Professor of English at the Department of English, University of Colombo, Sri Lanka. She holds a PhD from the University of Kent at Canterbury, UK and has been a visiting scholar at universities in the USA, including Yale, Rutgers, Amherst College and New York University. She is the author of *Militarizing Sri Lanka: Popular Culture, Memory and Narrative in the Sri Lankan Armed Conflict* (Sage 2007), and *Women and the Nation's Narrative: Gender and Nationalism in 20th Century Sri Lanka* (Kali for Women 2001); has co-edited a forthcoming book on the impact of the *tsunami* on women in Sri Lanka and has authored several articles on aspects of gender and cultural studies.

**Claudio Fuentes** holds a PhD in political science from the University of North Carolina at Chapel Hill (2003), and received the 2003 Best Dissertation Award by the Human Rights Section of the American Political Science Association (APSA). He was Director of the Latin American Faculty of Social Sciences, FLACSO-Chile (2004–8) and is currently the Director of the Social Science Research Institute (ICSO) at the Universidad Diego Portales in Santiago, Chile.

**Leymah Gbowee** is a co-founder and Executive Director of the Women Peace and Security Network (WIPSEN-Africa) a Pan-African women's peacebuilding organisation. As past Coordinator of Women in Peacebuilding Network's (WIPNET) Liberia chapter, she organised collaborative peacebuilding initiatives for a network of women peacebuilders called 'The Women of Liberia Mass Action for Peace Campaign'. She is the recipient of international awards for her peacebuilding activities, and is the central character of the award-winning documentary, *Pray the Devil Back to Hell*.

**Sanjana Hattotuwa** created and is the Editor of *Groundviews* ([www.groundviews.org](http://www.groundviews.org)), a pioneering award-winning web journalism initiative based in Sri Lanka. He publishes and speaks widely on media development, conflict resolution and using the internet for peacebuilding, both locally and internationally. He is a senior researcher at the

Centre for Policy Alternatives (CPA), Colombo, Sri Lanka.

**Jeffrey Isima** holds a PhD in politics from Cranfield University, UK. Having worked in Nigerian local government and for the Global Facilitation Network for Security Sector Reform (GFN-SSR), he is currently the Coordinator of the African Security Sector Network (ASSN). His main areas of research interest are security and development.

**Bassma Kodmani** is the Executive Director of the Arab Reform Initiative, a consortium of Arab and international think tanks with a joint programme on reform in the Arab world, and associate researcher at the Centre d'Etudes et de Recherches Internationales at Sciences-Po, Paris. Her research centres on social and political change in Arab societies and security in the Middle East. Her most recent book is *Abattre les Murs. Les Arabes et Leurs Craintes* (Paris: Liana Lévi 2008).

**Robin Luckham** is a post-retirement Research Associate at IDS with more than 40 years' experience working on the military, disarmament, democratisation, security and development, mostly in the context of sub-Saharan Africa. **Jenny Pearce** is Professor of Latin American Politics and Director of the International Centre for Participation Studies in the Department of Peace Studies at the University of Bradford. She is also a convenor of the violence, participation and citizenship thematic group with the Development Research Centre on Citizenship, Participation and Accountability at IDS. She is a specialist in issues of violence, conflict, social

change and social agency in Latin America. More recently, she has also worked on problems of participation and conflict in the north of England, following the Bradford riots of 2001.

**Michael Solis** is a Princeton in Latin America Fellow working for Human Rights Watch and FLACSO-Chile's citizen's security programme. Upon graduation from Princeton University in 2007, he worked for a year as a Luce Scholar for the National Human Rights Commission of Korea focusing on issues such as former Korean sexual slaves, immigrant rights, and discrimination against HIV/AIDS sufferers. He co-founded the Hmong Action Network and has participated in a number of projects to bring educational and medical services to impoverished communities in Mexico.

**Mohammad Osman Tariq** is currently working as Governance Advisor with the Asia Foundation, Afghanistan. He has an MA in Governance and Development from IDS. Tariq has 30 years' experience, being a fighter in the 1980s, working with the Taliban government and tribes, and being coordinator of the National Solidarity Program in the south-east region of Afghanistan.

**Silvia Varela** holds an MSc in International Security and Global Governance from Birkbeck College, University of London. She is a researcher at the Centre for Legal and Social Studies (CELS), Argentina, where she works on the Armed Forces Project, which seeks to

influence security decision-making; to advance institutional reforms in the security sector from a human rights perspective; and to uphold a democratic security agenda.

**Fiona Wilson** is a Professorial Fellow of IDS and team leader of its governance team and was, until this year, Professor of International Development Studies at the University of Roskilde, Denmark. She has worked on issues of authority and political violence in Peru since the 1990s, has published widely and is currently finishing a book on the history of radical political militancy in the Andes over the last 100 years.

**Susan L. Woodward** is Professor of Political Science at the Graduate Center, City University of New York, and currently senior fellow at the Fundación para las Relaciones Internacionales y el Diálogo (FRIDE), Madrid. A specialist on the Balkans, her current work is on state failure and post-conflict state-building. She has held professorships at North-western University, Williams College and Yale University; policy-research positions at the Brookings Institution and King's College, London; was head of the Analysis and Assessment Unit for the United Nations Protection Force (UNPROFOR) in 1994 and special adviser to the Organization for Security and Co-operation in Europe (OSCE) in Sarajevo in 1998. Her writings include (among others) *Balkan Tragedy: Chaos and Dissolution after the Cold War* (Brookings Press 1995).
