Michael Bamberger has almost 40 years of experience in development evaluation, including a decade working with NGOs in Latin America, almost 25 years working on evaluation with the World Bank in most of the social and economic sectors and in most regions of the world, and several years as an evaluation consultant. He has published three books on development evaluation, with the most recent a two volume study on *Influential Evaluations* (World Bank 2005). He has been active for 15 years with the American Evaluation Association, serving on the Board and as chair of the International Committee. He is on the Editorial Advisory Board of *New Directions for Evaluation*.

Sara Bandstein is a Research Fellow with the Swedish Agency for Development Evaluation (SADEV). She has a degree in economics within the Political Science and Economics Programme at Lund University. Before joining SADEV, Sara worked for the Swedish International Development Cooperation Agency (Sida) at the Secretariat for Evaluation and Internal Audit.
