Preface

This is an initial attempt at a comprehensive bibliography of Professor Dudley Seers' major publications and articles. For the sake of historical perspective (rather than the merits of presentation) I have decided to list his writings in chronological order of publication (as far as I have been able to establish it). A number of his articles have been reprinted in various volumes and symposia. Where this is the case I have tried to include as many citations as possible; but I realise that, with a little more research, the list of reprints could be greatly extended. Likewise I have included some references to translated books and articles but acknowledge that a great deal more of Dudley Seers' work has been published in many more languages than appears in this provisional listing. Review articles and minor writings have not been included and, though I have listed a few of his newspaper articles, I have made no attempt to include all of his national and international newspaper contributions. I have, however, tried to include all of his reports to international institutions and governments as well as his major articles, pamphlets and books. Due to the sheer volume of his work there will undoubtedly be omissions, possibly some important ones. Therefore I would welcome amendments and additions to this provisional bibliography. A fuller, revised version may be published separately by IDS at some future date.
