Danny Burns is Team Leader of the Participation, Power and Social Change Team at IDS. He was Professor of Social and Organisational Learning and co-Director of the SOLAR action research centre at the University of the West of England. Prior to that he worked at the School for Policy Studies at the University of Bristol. Danny has been Director of the Tenant Participation Advisory Service, Scotland, and the Decentralisation Research and Information Centre. He is author of *Systemic Action Research: A Strategy for Whole System Change* (Policy Press 2007).

Robert Chambers is a Research Associate in the Participation, Power and Social Change Team at IDS. His field experience has been mainly in East Africa and South Asia. He is the author of *Rural Development: Putting the Last First* (Prentice Hall 1983). His current concerns and interests include professionalism, power, the personal dimension in development, participatory methodologies, participatory teaching and learning with large numbers, seasonality, and Community-Led Total Sanitation.

Blane Harvey is a Research Fellow with the IDS Climate Change Team. He holds a PhD in Education and International Development from McGill University. Blane's work critically examines knowledge production, validation and dissemination processes within climate change, and culturally appropriate strategies and technologies for learning and knowledge sharing in the global South with a focus on North–South partnerships and inter-institutional cooperation. He is currently conducting research on the use of Information and Communication Technologies (ICTs), communications, and social learning in participatory North–South climate change initiatives, and on the potential of African community media to engage in action research and policy influence for climate justice.

Alfredo Ortiz Aragón is an Adjunct Professor at the Monterey Institute of International Studies (MIIS), where he designs and teaches courses and workshops on organisational sustainability,

human resource management, systemic thinking, proposal development and financial management of non-governmental organisations. He has worked for the last 12 years as an organisational development facilitator in Latin America, Africa, Asia and Europe, focusing on the linkages between organisational capacity and social change in complex environments. Alfredo is currently finishing his doctoral research at IDS, using action research to explore how capacity-building methodologies can support social change in complex and contested development realities.

Katy Oswald is a Research Officer in the Participation, Power and Social Change Team at IDS. She is interested in participatory action research as a process to support reflective learning and action. She is currently on leave from IDS, undertaking research in Nicaragua for her PhD.

Jethro Pettit is a Research Fellow with the Participation, Power and Social Change Team at IDS. He designs and facilitates transformative learning processes for social activists and development workers, aid organisations and university students.
