This weekly Covid-19, Conflict, and Governance Evidence Summary aims to signpost DFID and other UK government departments to the latest evidence and opinions on Covid-19 (C19), to inform and support their responses.

This week, features resources on: [Rohingya refugee experiences of C19 in the Cox's Bazar camps](#); how civil society can progress the [Women, Peace and Security agenda](#) during C19; how to address [intersecting risks from disasters and C19](#); and how C19 is affecting [peace, conflict and federalism in Nepal](#).

Many of the core C19 themes continue to be covered this week, including: surging [gender-based violence](#) during C19; increasing [food insecurity](#); the particular risks facing [refugees and displaced people](#); and [lessons from previous health crises \(Ebola\)](#).

The summary uses two main sections – (1) literature: – this includes policy papers, academic articles, and long-form articles that go deeper than the typical blog; and (2) blogs & news articles. See the end of this report for details on the method taken for this rapid summary. It is the result of one day of work, and is thus indicative but not comprehensive of all issues or publications.

Protecting the most vulnerable to cascading risks from climate extremes and the COVID-19 in South Asia	United Nations Economic and Social Commission for Asia and the Pacific; Policy study	How can the poor in South Asia be protected against climate extremes and C19? This study explores how the intersection of disaster risks (as monsoon season begins) and C19 require different policy approaches to tackle increasing poverty, malnutrition and food insecurity. It recommends: instituting early warning systems; managing climate risks; regional cooperation; local specific customised responses; risk-informed social protection; and scaling up index-based parametric insurance to target the most vulnerable.
Africa's Varied COVID Landscapes	Africa Centre for Strategic Studies; Article	How to understand the risk of C19 for African countries? This article analyses C19 risk profiles for African countries by creating a typology based on: size of population, dimensions of urban landscapes, magnitude of conflict and displacement, demography, and governance.
Lessons from the Ebola epidemics and their applications for COVID-19 pandemic response in sub-Saharan Africa	Muhammed O. Afolabi et al.; Developing World Bioethics; Journal article	What lessons from Ebola can inform the C19 response in sub-Saharan Africa? This journal article finds that the region has improved its ability to handle emergencies due to Ebola. Lessons suggest: strengthen regional coordination of epidemic responses in systems for handling research protocols, data sharing and sample transfer; strengthen community systems for prompt organisation and efficient epidemic responses in health education and promotion, and care facilities.
Impact of COVID-19 pandemic on	Kritika Poudel & Pramod Subedi;	How has C19 impacted on socioeconomics and mental health in Nepal? This journal article explains how C19 has increased fear, anxiety and uncertainty in Nepal. It argues for emphasising

socioeconomic and mental health aspects in Nepal	International Journal of Social Psychiatry; Journal article	and addressing coping strategies, mental health interventions, and awareness now as C19 may continue for an indefinite period.

<p>Federalism, conflict and peace in Nepal</p>	<p>Anurag Acharya, Ashlea Brewer, Swechchha Dahal & Ashim Pandey; Saferworld; Learning paper</p>	<p>What lessons are there from governance and conflict programming in Nepal? Related to C19, this paper finds that C19 brings to the fore underlying threats for federalism and stability that have been growing since the 2017 elections. Chaotic and poorly coordinated C19 responses are exacerbating accusations of corruption and further undermining public trust in their elected representative. Lockdown has impacted considerably on livelihoods and access to resources and services, with more severe pressures for poorer and more marginalised communities. Some communities have refused C19 relief support, alleging it is going to privileged community members who have access to the municipal government, and that it is leaving large numbers of poor residents deprived. C19 municipal, provincial and federal-level responses have been inadequate. The federal system is being tested in how it responds, public expectations are still high and patience in federalism's ability to deliver has worn thin.</p>
<p>Attacks on schools in the context of the COVID-19 pandemic</p>	<p>Insecurity Insight; Report</p>	<p>How is C19 affecting attacks on schools? This report identifies 67 attacks across 13 countries damaged or destroyed schools from January to May 2020. C19 challenges appear to influence these attacks, with a decline in the overall number of violently damaged schools since the pandemic was declared, compared to the previous two months of 2020. This is partially due to the ceasefire in Syria, and a ceasefire declared by Anglophone militants in the Ambazonia region of Cameroon. However, closure of schools and the use of school buildings as quarantine centres have triggered violence against school buildings in particular in South Africa. Violence against school</p>

		buildings also remains a concern in Burkina Faso, Mozambique, Ukraine, and Yemen.
2020 Civil Society Roadmap on Women, Peace and Security	NGO Working Group on Women, Peace and Security; Roadmap	How can the Women, Peace and Security Agenda be advanced? Related to C19, this paper finds C19 is amplifying existing gender, racial, economic and political inequalities, and impacting those most marginalised, including people with: diverse sexual orientation, gender identity, gender expression or sex characteristics (SOGIESC); disabilities; the elderly; the poor; and the displaced. Women are impacted due to their roles as primary caregivers or healthcare workers, and are often less able to meet their own needs due to structural inequalities. Women and girls in conflict-affected communities are likely more affected e.g. with the surge in gender-based violence (GBV), combined with essential service restrictions. Violence compounds existing risks for women and girls. Preventing all forms of GBV against women requires ensuring the autonomy and human rights of those targeted, and enabling them to lead and contribute to the responses, rather than only seeking to protect from violence. Women's rights must be central to C19 responses
Rohingya Experiences of Covid-19 in Cox's Bazar Camps	Saiful Haque, Zahid Uddin & Arshat Ullah; Political Settlements Research Programme; Report	How have the Rohingya experienced C19 in Cox's Bazar Camps? Based on interviews with 34 camp residents, this report finds: <ul style="list-style-type: none"> • Many camp residents have a very basic understanding of C19 and lack information on specific actions to protect themselves. • C19 negatively impacted the livelihoods of many residents – e.g. physical distancing especially affected shopkeepers and public-facing businesses. • Many residents say lockdown has severely constrained their ability to communicate with others. • Residents have been reticent to seek testing, isolation, and treatment in the clinics and hospitals available to them due to fears and rumours of ill treatment. • Many residents expressed distrust and noted a lack of open communication between themselves and humanitarian agencies in the

		camps (national and international agencies, and governmental authorities)
CDT Spotlight: Demonstrations in East Asia	Adam Miller; Armed Conflict Location & Event Data Project (ACLED); Infographic	How has C19 affected demonstrations in East Asia? Based on ACLED data, this infographic finds the majority of C19-related demonstrations have taken place in Japan, South Korea, and China. The reasons for demonstrations include: demands for economic support, demands for government enforcement of C19 precautions, and criticisms of government overreach.

Methodology

Due to the emerging nature of the Covid-19 crisis, this rapid weekly summary includes blogs, and news articles, in addition to policy and academic literature. The sources included are found through searches of Google Scholar, Google, and ReliefWeb with the keywords:

("COVID-19" OR "coronavirus") AND ("developing countries" OR "Africa" OR "Asia" OR "Middle East" OR "Latin America" OR "Pacific") AND ("conflict" OR "peace" OR "violence" OR "resilience" OR "fragility") OR ("authoritarian*" OR "democra*" OR "corrupt*" OR "transparency" OR "state legitimacy" OR "non-state actors" OR "state capacity" OR "state authority" OR "politic*" OR "state institutions")

The searches are restricted to articles published in the previous seven days, in English. This is complemented by: a focussed Twitter search (using just the pages of a small selection of research organisations, and key scholars/thinkers, including those funded by the UK government's Department for International Development (DFID)); and through email recommendations from DFID advisors and leading experts.
