

Notes on Contributors

Arnab Acharya is a senior lecturer in quantitative health economics at the London School of Hygiene and Tropical Medicine. He obtained his PhD in microeconomic theory, and now works on applications of econometrics and economic theory to health policy in developing countries. Specific topics of interest include impact evaluation as well as economic evaluation of health interventions, improving service delivery for the poor, the relation between health and economic growth and normative issues around the concept of health inequality. He is particularly involved in policy research in India, Bangladesh, Brazil, Tanzania and Malawi.

Poulomi Chakrabarti has a Masters degree in City Planning (with specialisation in International Development) from the Massachusetts Institute of Technology. The article in this *IDS Bulletin* is part of her Masters thesis, which explores the impact of the rise of middle-class activism on local governance in Indian cities. This research forms part of larger cross-national study on collective action and modes of service delivery carried out by the Institute of Development Studies (IDS). She previously worked as a consultant on urban development at the Energy and Resources Institute (previously Tata Energy Research Institute) in New Delhi.

Monika Dowbor has been a researcher at the Brazilian Centre for Analysis and Planning (CEBRAP) since 2006. She has also worked as a teacher in cooperatives using the methodology of Paulo Freire, and as a manager of social and educational projects in non-governmental organisations (NGOs). She was Director of a recently completed research project, funded by the Ford Foundation, concerning 'Dialogue on Democracy and Pluralism in South Asia'.

Adrián Gurza Lavalle has been fellow researcher at the Brazilian Centre for Analysis and Planning (CEBRAP) since 2001. He is a Professor at the Political Science Department in the University of São Paulo. His focus is on political theory, comparative politics and civil society, and his main field of research is on civil organisations politics.
